WHEREAS the excessive wind and rainfall and subsequent overland flooding experienced on August 24 and 25, 2024 in the Gypsumville, St. Martin and Fairford areas of the Rural Municipality of Grahamdale has caused extensive damages and costs to municipal infrastructure;

AND WHEREAS the excessive wind and rainfall and subsequent overland flooding has created a critical situation and unreasonable financial burden for agricultural producers (livestock, grain, crops) individuals, residential homes and businesses.

AND WHEREAS the Municipality declared a State of Local Emergency on August 26, 2024;

AND WHEREAS the Province of Manitoba through the Manitoba Emergency Management Organization provides disaster financial assistance for damages and costs incurred.

THEREFORE BE IT RESOLVED that the R.M. of Grahamdale request the Province of Manitoba create a Disaster Financial Assistance Program to provide Disaster Financial Assistance to the Rural Municipality of Grahamdale and its affected residents for all costs/damages incurred due to the August 24 and 25, 2024, High Winds, Excessive Rainfall and Overland Flooding Event.
